



## The school will:

- \* Provide a balanced curriculum and meet the needs of each child, supporting children's social and emotional needs as they return to the school environment
- \* Arrange the learning environment and provide individual resources to promote infection control
- \* Alter the school day and arrangements to promote social distancing between bubble groups
- \* Continue to follow an adapted version of our 'Good to be Green' behaviour policy
- \* Make sure children wash their hands regularly and thoroughly
- \* Inform parents/carers about their child's progress on a termly basis
- \* Encourage mutual respect between pupils and adults
- \* Educate children regarding their own well-being, safety and the dangers found online.

## Home School Agreement September 2020

### Parents/Carers must:

- \* Inform the school of any medical or dietary needs, or any concerns or problems that might affect their child
- \* Update all contact details
- \* Respect the decisions made by school and understand that the safety and welfare of children and staff must come first
- \* Support the school's behaviour policy
- \* Arrive at the identified location, at the designated time, to drop off and collect your child. Ensure you are on time.
- \* Send their child into school every day possible to reduce the gaps in learning due to absences
- \* Monitor their child's use of the internet and social networking sites, ensuring their child adhere to the age restrictions and advice given on e- safety
- \* Be available for Parent Consultations to discuss their child's progress
- \* Encourage mutual respect between pupils and all staff by modelling positive behaviours at all times
- \* Build positive working relationships with their child's class teacher and other adults in their child's class
- \* Wherever possible, do not come in pairs or groups to drop off/collect your child (1 parent/carer only)
- \* Contact the office by telephone or email
- \* Ensure their child is in full school uniform or PE kit on their designated PE day
- \* Maintain social distancing AT ALL TIMES to minimise the risk to everyone
- \* Adhere to the one way systems in place around school.



### The child must:

- \* Follow the school rules, good to be green policy and embrace our core values
- \* Consider the feelings of their peers and all staff (including lunchtimes supervisors and office staff)
- \* Wear the school uniform with pride and be a school ambassador whenever they are wearing it
- \* Always tell a member of staff about their problems / concerns that stop them from feeling happy and safe
- \* Always respect themselves and others
- \* Respect all adults within school
- \* Respect the school's property, their own and the property of their peers
- \* Stay at their individual work station unless instructed by their adult
- \* Wash their hands regularly and thoroughly
- \* Remember to use a tissue when sneezing or coughing
- \* Bring in a water bottle which is taken home each day to be cleaned thoroughly
- \* Not bring any unnecessary items into school, including backpacks, PE kits, toys, pencil cases
- \* Keep long hair tied back and do not wear jewellery (except a single pair of stud earrings).



## **Home School Agreement September 2020**

*Together we aim to provide a place to grow in a caring environment for learning, in which your child can develop confidence as an individual and as a member of the wider community.*



### Parent/Visitor Conduct On Site

Parents / visitors are expected to treat all staff and children in a respectful way when on our school site. Any threatening, abusive or violent behaviour against any staff member or child is taken extremely seriously. Examples of such behaviour are below:

- raised voices
- shouting at staff
- swearing
- intimidating staff
- rallying other parents to become involved in intimidating behaviour
- publically voicing unsubstantiated claims about staff, children or the Academy.
- using racist or sexist terms
- using violence
- taking alcohol or drugs on the premises
- willful damage to school property
- theft
- threats or threatening behaviour
- altercations (verbal or physical towards other parents whilst on the school site).

This list is not an exhaustive list but seeks to provide illustrations of such behaviour that is not acceptable in our school.

Anyone behaving in this way will be asked to leave the premises and the police will be called if verbal or physical harassment occurs. If necessary, action will be taken to ban anyone behaving in such a way from the school grounds.

- ◇ Whilst the COVID 19 pandemic continues, we will be reviewing all procedures constantly to ensure that we are doing our best to keep everyone as safe as we possibly can—following government guidelines for schools.

### **Reminder**

- ◇ It is not possible for parents/carers to meet face-to-face with staff, unless this is a pre-arranged meeting
- ◇ It is not possible for parents/carers to go to the school office in person—please call or send an email
- ◇ We politely ask parents/carers to not congregate around drop off/collection points to ensure that our one way system runs smoothly.
